INJURY OR HEALTH PROBLEM WITH A PERSON:

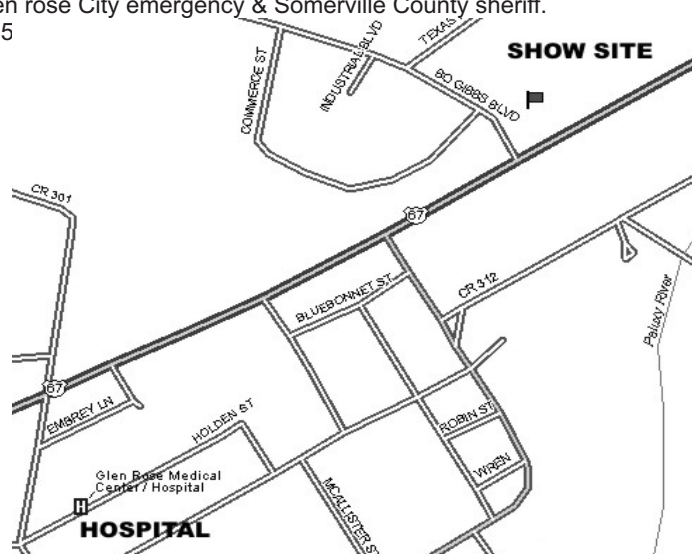
